
FLORIDA CHARTER No. P05000074568

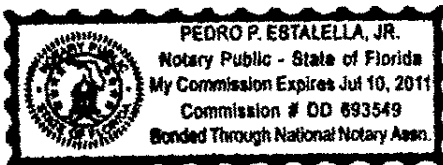
