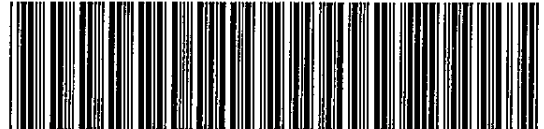

incorporated pursuant to the Florida General Corporation Act, forms  
a corporation for profit.

ARTICLE I

The name of this corporation shall be REALTYME INVESTMENTS,

The purpose of this corporation is to transact any and all

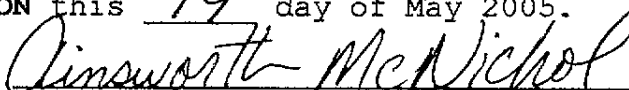
#### ARTICLE IX
