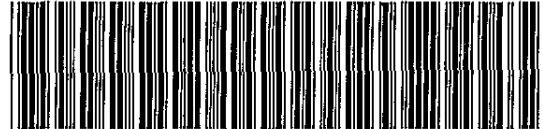

ARTICLE I NAME

The name of this corporation is **VANCE INVESTMENTS VCI, INC.**

ARTICLE II DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

ARTICLE III PURPOSE

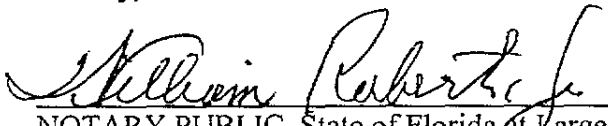
