

I. the undersigned, being of legal age and a natural person, do hereby subscribe to, acknowledge, and file the following Articles of Incorporation for the purpose of creating a corporation under the Laws of the State of Florida.

#### **ARTICLE I**

The name of the corporation shall be:

#### ARTICLE II
