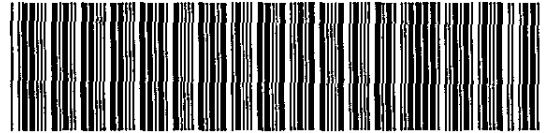

**ARTICLE I - NAME AND BUSINESS ADDRESS**

The name of this Corporation is COLORS ENTERTAINMENT, INC. Its principal office address and business mailing address is 6735 N.W. 192<sup>ND</sup> Lane, Miami, Florida 33015.

**ARTICLE II - DURATION**

The Corporation shall have a perpetual existence.

**ARTICLE III - PURPOSE**




