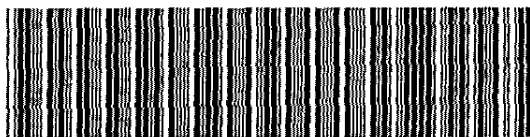

ARTICLES OF INCORPORATION

ARTICLE 1 – NAME

The name of this corporation is Clato Properties, Inc.


ARTICLE IX – AMENDMENTS
