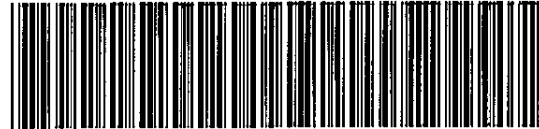

## ARTICLES OF INCORPORATION

#### ARTICLE VIII




