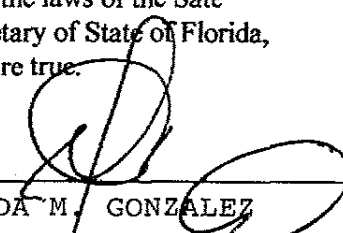

Article – Fourteen

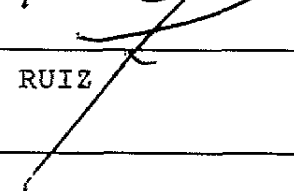
