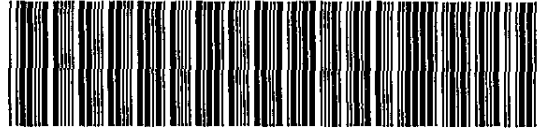

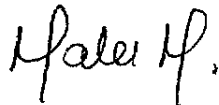

ARTICLE ONE:

The name of the corporation is: Alropa Services, Inc.


