Article I - Name

The name of this corporation is SEASONS DEVELOPMENT GROUP, INC.

Article II - Principal Place of Business



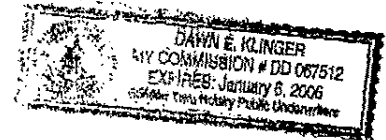
