ARTICLE I

Name of the Corporation

Nature of Business



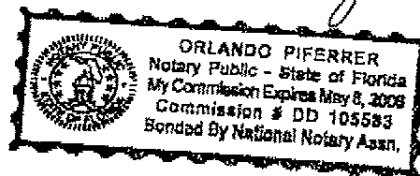
