ARTICLES OF INCORPORATION

OF

INDIGOSKYS GROUP, INC.

SECRETARY OF STATE

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

- Article 1. Name. The name of the Corporation is: INDIGOSKYS GROUP, INC. The principal office of the Corporation is 5538 Willow Bend Trail, Kissimmee, Florida 34758. The mailing address of the Corporation is 20 N. Orange Avenue, Suite 600, Orlando, Florida 32801.
 - Article 2. Duration. The duration of the Corporation is perpetual.


