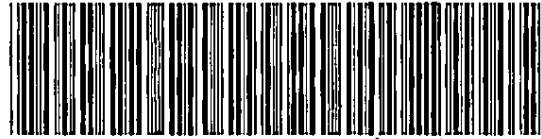

Dissolution of the corporation was approved and authorized on OCT 18, 2017.


ARTICLE III. APPROVAL OF DISSOLUTION
