The undersigned incorporator to these Articles of Concernation hereby forms Arnold Insurance & Financial Services,

Inc. a corporation under the laws of the State of Florida as follows:

# ARTICLE I

# Name and Address

The name of this Corporation is: Arnold Insurance & Financial Services, Inc. The street and mailing addresses of the Corporation are: 101 South Courtenay Parkway, Suite 103, Merritt Island, Florida 32952.

# ARTICLE II

# Term of Existence

This Corporation shall have perpetual existence, commencing upon the filing of these Articles of Incorporation with the Florida Department of State.

# ARTICLE III

# <u>Purpose</u>

This Corporation is organized for the purpose of transacting any and all lawful business.

#### ARTICLE IV

#### Powers

The Corporation shall have the power:

- (h) To make contracts and guaranties and incur liabilities, borrow money at such rates of interest as the Corporation may determine, issue its notes, bonds, and other obligations, and

secure any of its obligations by mortgage or pledge of all or any of its property, franchises, and income.
