The undersigned, for the purpose of forming a corporation under the laws of the State of TATE Florida, do hereby adopt the following articles of incorporation:

ARTICLE ONE

The name of the corporation shall be: SJD Construction Consultants, Inc.

CORPORATE DURATION

The duration of the corporation is perpetual.
