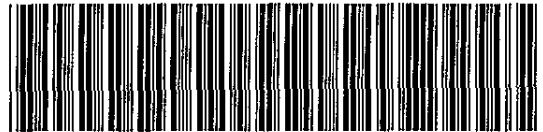

The undersigned, for the purpose of forming a corporation under the laws of the State of Florida, do hereby adopt the following articles of incorporation:

TALLAHASSEE, FLORIDA

ARTICLE ONE

The name of the corporation shall be: SJD Construction Consultants, Inc.

ARTICLE TWO

CORPORATE DURATION

The duration of the corporation is perpetual.

ARTICLE THREE

PURPOSE OR PURPOSES

The general purposes for which the corporation is organized are:

1. To acquire, hold, purchase, exchange, sell, convey, lease, mortgage, pledge, improve, alter, manage, develop and otherwise deal and trade in real and personal property of every kind and description.

2. To manufacture, make, assemble, build, process, develop, acquire, purchase, sell, hold, mortgage, pledge, exchange, assign, transfer, invest and deal in and with goods, machines, wares, merchandise, equipment, and personal property of every class and descriptions; and to conduct and carry on any business in connection therewith and incidental thereto.

3. To acquire, hold, purchase, exchange, sell, convey, lease, mortgage, erect, construct, alter, manage, operate, consult, and improve buildings and structures of all kinds and descriptions; and to operate, manage, lease, control and conduct any and all business incidental thereto, and in connection with.

4. To purchase, sell, hold, assign, transfer, mortgage, pledge, hypothecate, or otherwise acquire or dispose of the shares of capital stock or bonds, securities or otherwise evidences of indebtedness created by any person or corporation of this or any other state, country, nation, or government, and while owner of said items, to exercise all the rights and privileges of ownership, including the right to vote thereon as natural persons might or could do; and to exercise and have any and all powers, rights and privileges granted to and conferred upon corporations by and under the General Corporation Laws of the State of Florida.

5. To engage in any other trade or business which can, in the opinion of the board of directors of the corporation, be advantageously carried on in connection with or auxiliary to the foregoing business.

6. To do such other things as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing.

ARTICLE FOUR

CAPITALIZATION

The aggregate number of shares which the corporation is authorized to issue is 10,000. Such shares shall be of a single class, and shall have a par value of One Dollar (\$1.00) per share payable in lawful money of the United States of America or in other property, tangible or intangible, or in labor or services actually performed for the Corporation at a just valuation to be fixed by the Board of Directors or the shareholders of this Corporation. The Capital stock of the Corporation may at any time be increased or decreased as provided by the laws of Florida .

ARTICLE FIVE

REGISTERED OFFICE AND AGENT

The street address of the initial registered office of the corporation is 5508 Lake Leta Blvd., Tampa, Florida 33624 and the name of its initial registered agent at such address, is Shawn J. Dusendang.

ARTICLE SIX

DIRECTORS

The number of directors constituting the initial board of directors of the corporation shall not be less than one (1) and not more than five (5); the exact number to be determined by the Bylaws, or by special vote of stockholders.

ARTICLE SEVEN

INDEMNIFICATION

The Corporation shall indemnify any officer, director or employee of the Corporation or any former officer director or employee of the Corporation to the full extent permitted by and as set forth in the Florida General Corporation Law.

ARTICLE EIGHT

AMENDMENT

Unless otherwise set forth herein, the Corporation reserves the right, in accordance with the Florida General Corporation Law, to amend, alter, modify or repeal any provision or provisions contained in these Articles of Incorporation or any amendment hereto and any right conferred upon the Shareholders is subject to this reservation.





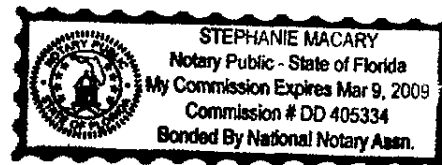
