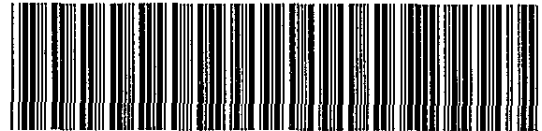


ARTICLE X - AMENDMENT




