The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, dues hereby adopt the following Articles of Incorporation:

ARTICLE I - NAME

A. Any stock of any class that the Corporation may issue or sell, whether or not

exchangeable for any stock of the Corporation of any class or classes, and whether or not of

unissued shares authorized by the Articles of Incorporation as originally filed or by any

amendment thereof or out of shares of stock of the Corporation acquired by it after the issuance

thereof, and whether issued for cash or other consideration; or

B. Any obligation that the Corporation may issue or sell which is convertible into or

exchangeable for any stock of the Corporation of any class or classes, or to which is attached or

pertinent any warrant or warrants or other instruments conferring on the holder the right to

subscribe for or purchase from the Corporation any shares of its stock of any class or classes.
