**ARTICLES OF AMENDMENT
TO THE
ARTICLES OF INCORPORATION
OF
OBSTETRICS AND GYNECOLOGY ASSOCIATES OF COLLIER COUNTY, P.A.**

Pursuant to the provisions of the Florida Professional Service Corporation and Limited Liability Company Act, OBSTETRICS AND GYNECOLOGY ASSOCIATES OF COLLIER COUNTY, P.A., a Florida professional association (the "Corporation"), adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The Articles of Incorporation for Obstetrics and Gynecology Associates of Collier County, P.A. were filed on May 25, 2005, and assigned document number P05000076431.

SECOND: The following amendment to the Articles of Incorporation was adopted by the sole shareholder on January 16, 2006. The number of votes cast for the amendment by the shareholder was sufficient for approval.

The first article of the Articles of Incorporation of the Corporation shall be amended in its entirety to read as follows:

FIRST: The name of the professional association (the "Corporation") is the "**WOMEN'S AND CHILDREN'S PHYSICIANS OF NAPLES, P.A.**"
