#### ARTICLES OF INCORPORATION OF NZ CLUB MARKETING, INC.

I, the undersigned natural person of the age of eighteen (18) years or more, acting pursuant to Chapter 607 of the Florida Statutes as incorporator of NZ Club Marketing, Inc. (the "Corporation"), hereby adopt the following Articles of Incorporation for the Corporation.
