



## ARTICLES OF INCORPORATION

OF

#### ARTICLE I. NAME

The name of this corporation is METIS CARPENTRY, INC.

#### ARTICLE II. DURATION

This corporation shall have perpetual existence.

#### ARTICLE III. PURPOSE
