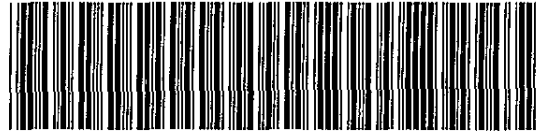



**ARTICLES OF INCORPORATION
OF

ARTICLE I—NAME

The name of this corporation is **Accurate "Ace" Appraisal, Corp.**

ARTICLE II—DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.


