**FIRST:** The undersigned

being at least eighteen years of age, do(es) hereby form a corporation under the laws of the State of Florida.

**SECOND:** The name of the corporation is: **ALLENS of DIXIE, Inc.**  
The corporation shall be a close corporation.

**THIRD:** The purpose of the corporation is to engage in any lawful act or activity for which a corporation may  
Be organized under the laws and statutes of the State of Florida.

**FOURTH:** The duration of the corporation is: "perpetual".

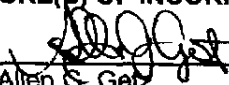
**SEVENTH:** The corporation has authority to issue only one class of shares of stock. The corporation has authority
