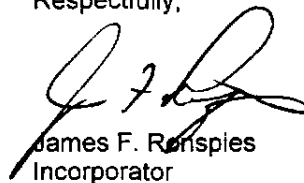

ARTICLE ONE

The name of the corporation is ODESSA ELECTRICAL MANUFACTURERS, INC. The principal office of the corporation is 280 Scarlet Boulevard, Oldsmar, Florida 34677.

ARTICLE TWO

The period of duration is perpetual.

ARTICLE THREE

The purpose for which the corporation is organized is the transaction of any and all lawful business for which corporations may be incorporated under the Florida Corporation Act.

The Board of Directors is empowered to make, alter or repeal the bylaws of the corporation without restriction of their powers conferred by statute.

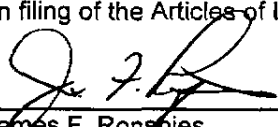

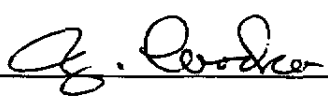

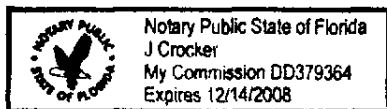
