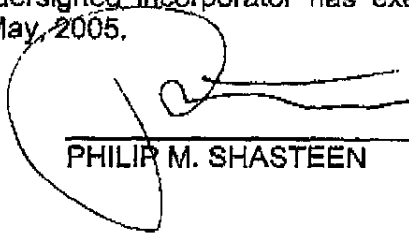
ARTICLE VI - Indemnification
