

SECOND. The foregoing amendment was duly adopted by the sole shareholder and Director of the corporation on the 20th. day of October 2005.

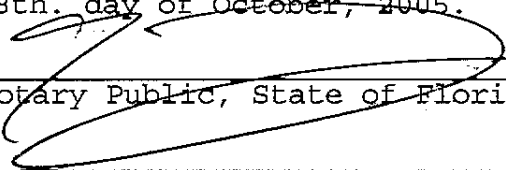
THIRD. The amendment was approved by the shareholders. The number of votes cast for the amendment was sufficient for approval.
