

ARTICLES OF INCORPORATION

OF

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

Article I

The name of the corporation is: **Tailored Heuristics, Inc.** The principal place of business of this corporation shall be 26611 Bimini Drive, Tavares, FL 32778.
