#### RON JON SURFPARKS, INC.

The undersigned, acting as the Incorporator of RON JON SURFPARKS, INC., a Florida corporation (the "Corporation"), pursuant to Chapter 607 of the *Florida Statutes*, hereby forms a corporation for profit under the laws of the State of Florida and adopts the following Articles of Incorporation for the Corporation:

#### ARTICLE I - NAME

The name of the Corporation is RON JON SURFPARKS, INC. The mailing address of the Corporation shall be 3850 South Banana River Boulevard, Cocoa Beach, Florida 32931.

#### ARTICLE II - CORPORATE EXISTENCE
