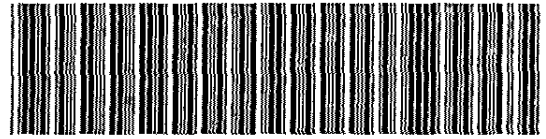

ARTICLE I. NAME AND ADDRESS


ARTICLE X. INDEMNIFICATION


