ARTICLES OF INCORPORATION

OF

FLORIDA DEATH & CRIME SCENE CLEANING, INC.

The undersigned, acting as incorporators of a corporation under the Florida Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST

The name of this corporation is FLORIDA DEATH & CRIME SCENE & CLEANING, INC.

SECOND

The period of duration of the corporation is perpetual.

THIRD

The purpose or purposes for which the corporation is organized are to clean death and crime scene premises, to engage in any activity or business permitted under the laws of the United States and of this state, and to do everything necessary, proper, advisable, or convenient for the accomplishment of said purposes, and to do all other things incidental to them or connected with them that are not forbidden by the Florida corporate laws or by other law, or by these articles of incorporation, and to carry out the said purposes in any state, territory, district, or possession of the United States, or in any foreign country, to the extent that

these purposes are not forbidden by the law of the state, territory, district, or possession of the United States, or by the foreign country.

FOURTH:

Authorized Shares

Number. The aggregate number of shares of stock that the corporation shall have the authority to issue is Five Thousand shares (5,000), of capital stock at a value of One Dollar (\$1)per share.

Initial issue. Two Thousand (2000) shares of the Capital Stock of the corporation shall be issued for cash at a value of One Dollar (\$1) per share.

Stated Capital. The sum of the value of all shares of Capital Stock of the corporation that have been issued shall be stated capital of the corporation at any particular time.

No Classes of Stock. The shares of the corporation are not to be divided into classes.

No Shares in Series. The corporation is not authorized to issue shares in series.
