## ARTICLES OF INCORPORATION

OF

#### MICHAEL R. SAUNDERS DEVELOPMENT, INC.

The undersigned incorporator, MICHAEL R. SAUNDERS, a natural person competent to contract, hereby presents these Articles of Incorporation for the formation of a corporation under the provisions of Chapter 607, Florida Statutes.

#### **ARTICLE I - NAME**

The name of this corporation is MICHAEL R. SAUNDERS DEVELOPMENT, INC.

### ARTICLE II - PRINCIPAL OFFICE

The street and mailing address of the corporation's principal office is 1325 Whitlock Lane, Suite 306, Carrollton, TX 75006.

#### <u>ARTICLE III - PURPOSE</u>

This corporation is organized for the purpose of transacting any and all lawful business under the laws of the State of Florida and the laws of the United States.
