# DEPAIVA SERVICES, CORP.

The undersigned subscriber to these Articles of Incorporation is a Natural Person competent to contract and hereby form a Corporation for profit under Chapter 607 of the Florida Statutes.

#### **ARTICLE I - NAME**

The name of this corporation is **DEPAIVA SERVICES**, CORP. (Hereinafter, "Corporation").

#### ARTICLE IX POWER OF CORPORATION
