ARTICLES OF INCORPORATION OF

ARTICLE 1. - NAME

The name of this corporation is **TRADEWINDS TITLE SERVICES, INC.**

ARTICLE 2. - PRINCIPAL OFFICE; MAILING ADDRESS

Tamiami Trail, Unit A, North Port, FL 34287. The corporation may change its principal office and/or mailing address from time to time as permitted by law.

ARTICLE 3. - PURPOSE
