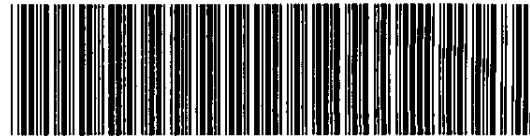



**ARTICLES OF AMENDMENT  
TO ARTICLES OF INCORPORATION OF  
CORNERSTONE TRANSPORTATION SERVICES INC**
