**ARTICLES OF INCORPORATION
OF
WORKSTATIONS, ETC., INC.**

ARTICLE I - NAME AND PRINCIPAL ADDRESS

The name of the corporation is WORKSTATIONS, ETC., INC., and the principal address and principal place of business is 10845 124TH AVENUE NORTH, LARGO, FLORIDA 33778.

ARTICLE II - REGISTERED OFFICE AND AGENT
