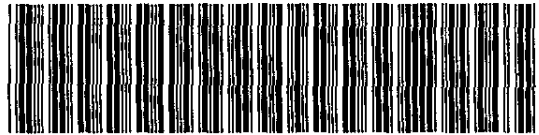

Dissolution of the corporation was approved and authorized on MARCH 10, 2006.

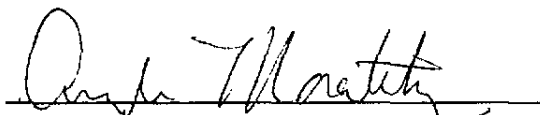
ARTICLE III. APPROVAL OF DISSOLUTION
