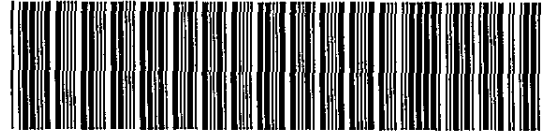

ARTICLE I
CORPORATE NAME
