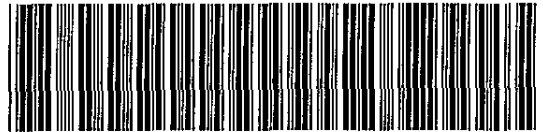

## **ARTICLES OF INCORPORATION**

In Compliance with Chapter 607 and/or Chapter 621, F.S. (Profit)

The undersigned, for purpose of forming a corporation under the laws of the State of Florida, do hereby adopt the following articles of incorporation:

### **ARTICLE 1 NAME**

The name of the corporation is Boston Pizzeria Inc.

### **ARTICLE 2 DURATION**


