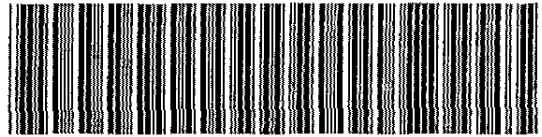

ARTICLE I - NAME

The name of this corporation is FABULOUS FLORALS, Inc.

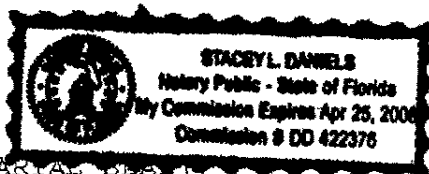
