# ARTICLES OF INCORPORATION GILMAN YACHTS OF TAMPA BAY, INC.

SECRETARY OF STATE TALLAHASSEE FLORIDA

The undersigned, acting as Incorporator of a Florida corporation under the Florida Business Corporation Act, Chapter 607 of the Florida Statutes, hereby causes to be delivered the following Articles of Incorporation:

## ARTICLE I NAME

The name of the corporation shall be Gilman Yachts of Tampa Bay, Inc. (hereinafter, the "Corporation").

#### ARTICLE II PRINCIPAL AND MAILING ADDRESS
