# ARTICLES OF INCORPORATION OF

The undersigned incorporator, RONALD BRUCE BARNE'IT, a natural person competent to contract, hereby presents these Articles of Incorporation for the formation of a corporation under the provisions of Chapter 607, Florida Statutes.

#### ARTICLE I - NAME

#### ARTICLE II - PRINCIPAL OFFICE
