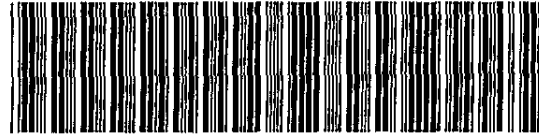

ARTICLES OF INCORPORATION
OF

The undersigned incorporators, for the purpose of forming a corporation for profit under the laws of Florida, hereby adopt the following Articles of Incorporation:

ARTICLE I
