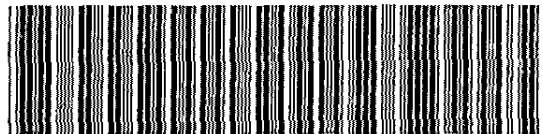

ARTICLES OF INCORPORATION

OF

RDF TRIM CARPENTRY, INC.

ARTICLE I - NAME

The name of this corporation is RDF TRIM CARPENTRY, INC.

ARTICLE II - DURATION

This corporation shall exist perpetually.
