

## ARTICLES OF INCORPORATION OF WH CON, INC.

**THE UNDERSIGNED,** acting as sole incorporator of WH CON, INC. under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

#### ARTICLE I NAME
