#### ARTICLE I. CORPORATE NAME.

The name of this Corporation is: **CREATURE COMFORTS PET RESORT**, **INC.** 

### ARTICLE II. ADDRESS OF PRINCIPAL OFFICE.

The initial street address of the principal office and the mailing address of this Corporation is: located in Duval County at 5534 Park Street, Jacksonville, Florida 32205. The Board of Directors may from time to time move the principal office to any other address in Florida.

# ARTICLE III. NATURE OF BUSINESS AND POWERS.

The Corporation may engage in any activity legal under the laws of the State of Florida.
