ARTICLES OF INCORPORATION

TALLAHASSEE, FLORIDA

TMMACULATE AUTO REFINISHING AND DETAILING INC.

The undersigned, acting as incorporator(s) of a corporation under the Florida General Corporation Act, adopt(s) the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is IMMACULATE AUTO REFINISHING AND DETAILING INC.

SECOND: The period of duration of the corporation is perpetual.
