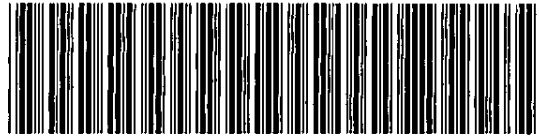

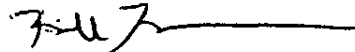

Pursuant to § 607.1006, *Florida Statutes*, this Florida professional corporation adopts the following amendment to its Articles of Incorporation:

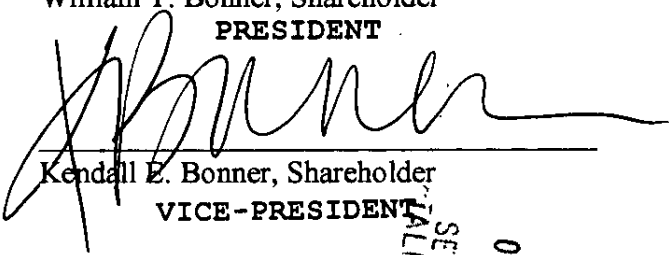
1. The name of the corporation is WILLIAM T. BONNER, P.A.
