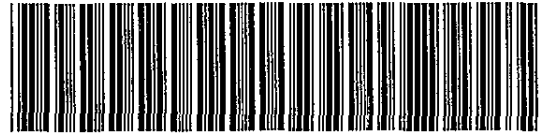

Name

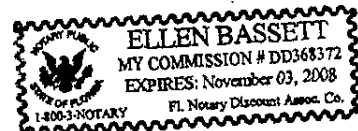


