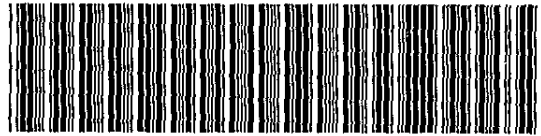



**ARTICLES OF INCORPORATION**  
**OF**  
**AMERICAN PRIDE SANITARY SERVICES, INC.**

The undersigned, acting as incorporator, hereby adopts these Articles of Incorporation and forms a for - profit corporation (the "Corporation") under the laws of the State of Florida as follows:

**1. NAME**

The name of the Corporation is:

American Pride Sanitary Services, Inc.

**2. TERM OF EXISTENCE**

The date when the corporate existence shall commence shall be the date of the filing of these Articles of Incorporation, and the Corporation shall have perpetual existence thereafter.

**3. PURPOSE**

The initial Board of Directors shall have one member whose name and address is as follows:



## 7. INCORPORATOR


