The undersigned incorporator for these Articles of Incorporation, a natural person over the age of eighteen years, competent to contract under the laws of State of Florida, hereby presents these Articles of Incorporation for the formation of a corporation under the Corporation Act, and other S laws of the State of Florida. **1- NUL**

ARTICLE I. NAME

The name of the corporation is NUTRITIONAL PRODUCTS COMPANY.

ARTICLE II, NATURE OF BUSINESS

The general nature of the business to be conducted by the corporation is:
